1. All parties understand that this agreement is a contract for photographs.
2. Cutting Edge Images, Inc. will photograph the Torah portrait session, and party only, unless otherwise arranged with the photographer.
3. All the photographs become the property of the contracting party.
4. At no cost to the contracting party, Cutting Edge Images, Inc. reserves the right to create duplicate photographs, at the time of the initial printing, to be used for future business illustrations or advertising.
5. All care will be taken with the negatives and photographs; Cutting Edge Images, Inc. limits all liability for loss, damage, stolen or failure to deliver for any reason to a complete refund of all payments made.
6. A non-refundable deposit of 20% of the subtotal calculated below will be paid upon signature of this contract. This guarantees that Cutting Edge Images, Inc. reserves the date(s) for the event. No other event will be reserved for those date(s) and time. The adjusted balance due is to be paid upon delivery of the photographs.
7. Cutting Edge Images, Inc. reserves the right to hire another photographer in the event of illness or scheduling conflict. In the event of such substitution, photographer warrants that the hired photographer will be a competent professional.
8. If I, Cutting Edge Images, Inc., am unable to perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to photographer illness or emergency, then the deposit shall be fully returned to the signing client, but shall have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or other media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer.

9. Upgrades in package selection after the initial signing of this contract are subject to prices at the time of upgrade.
10. Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and client releases Cutting Edge Images, Inc. from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
11. Client is aware that he/she must inform photographer prior to the event of any special photographs that are to be taken on event day. Any missed photographs are not the responsibility of the photographer, if the photographer was not made aware of a particular photo that needed to be taken. Cutting Edge Images, Inc. will act in accordance with event standards to ensure all special moments are captured, but will not be held responsible for persons not photographed.
11. Upon completion of your event, all UNEDITED photos will be uploaded to the company website at www.ceimitzvahs.com to be selected by the client as photos to be edited. After the selection process, the photos selected by the client will be edited by Cutting Edge Images, Inc., A DVD of all edited images can be purchased for an additional \$300 to be sent to the client for personal reproduction only, but is included in some package options. By signing this contract, Client and Cutting Edge Images, Inc. agree that the photos can be reproduced by the client for personal reproduction only, and that this is a copyright release for said purpose. Absolutely NO files will be emailed to the client at any time, nor will a flash drive or other USB device be given to the client.
13. Please note, that absolutely NO UNEDITED PHOTOS will be given to the client prior to them being edited by the photographer and distributed to the client on the DVD. This is to ensure that all photographs posted on social media or otherwise distributed will be of top quality and up to Cutting Edge Images, Inc. quality standards. Cutting Edge Images, Inc. does, however, reserve the right to post images on social media prior to delivery to the client for advertising purposes.
14. If the client would like to have a printed album, please discuss this with the photographer. Each Album will be an additional \$700, and can be fully customizable. Details will be discussed at a separate time with the client.
15. Only basic photo touchups will be done to the photographs free of charge (color correction, cropping, and brightness correction.) All other edits requested by the signing party will be charged at a rate of \$10/photo. This includes, but is not limited to, fixing double chins, removing people from photos, skin blemishes, etc.
16. Please allow 2-3 weeks after your event for the original unedited photos to be posted on the website for selection. After that, please allow another 4-5 weeks for editing of client-selected images before the DVD/ &/or Album will be mailed out to ensure a top quality editing process.
17. NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs or videos for commercial purposes without the permission of Cutting Edge Images, Inc., and violators of this Federal Law will be subject to its civil and criminal penalties.
18. All photos posted on social media, printed, or otherwise distributed may not be done so without photographer consent if prior to full editing and distribution of said photographs to the client/signing party. If the signing party/client distributes photos, prints them, posts on social media, or otherwise distributes photos and/or files prior to receiving fully edited photos, the client will be charged accordingly for said photos. Legal action may be taken if client refuses payment.
19. This contract incorporates the entire understanding of the parties and is governed by the laws of Atlanta, Georgia. Any modifications of this contract must be in writing and signed by both parties.

20. Late Payment Policy: All payments must be due IN FULL within **30 days** of the completion of your event unless otherwise worked out between you and the photographer. All late payments past that due date will be subject to an additional 10% charge on your remaining balance for every 30 days thereafter that full payment is not received. Please understand that contracting party is more than happy to work out a payment schedule if need be, however, this must be agreed to before the contract is first signed.
